## When you contact us

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. ## **Information Security**

We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted. (You many request the deletion of your data held by North Lodge Parish Council at any time).

### Children

We will not process any data relating to a child (under 13) without the express parental/guardian consent of the child concerned.

### **Access to Information**

#### **Information Correction**

## **Right to Object**

## Rights Related to Automated Decision Making and Profiling

North Lodge Parish Council does not use any form of automated decision making or the profiling of individual personal data.
