NORTH LODGE PARISH COUNCIL

Minutes of the Meeting of North Lodge Parish Council held at Park View Community School, Lombard Drive, Chester-le-Street on Tuesday 19th July 2011.

The meeting commenced at 6.30pm with the Chairman welcoming everyone. Councillor Mrs. S. Brown was not present at the start of the meeting.

Item 1. 11/80 Apologies for Absence

Apologies for Absence were received from Councillors Mrs. M. Caygill, Mrs. L. LeDune, Prof. V. McEwan, C. Jukes and S. Tones, and from County Councillor J. Cordon and PCSO L. Hunter. The Clerk advised that an e-mail had been received from Cllr. Prof. McEwan stating her intention to tender her resignation from the Council. Councillors were unanimous in their disappointment at this news. The Clerk is to contact Cllr. Prof. McEwan to advise that the Council does not require a final decision immediately and hopes a way might be found to enable her to remain a Councillor.

Item 2. 11/81 Report of the Police

In the absence of the Police, PCSO L. Hunter had provided a written report (Appendix 1, attached) and this was read by the Clerk.

The Chairman thanked PCSO Hunter, in her absence, for providing the report.

Item 3. 11/82 Reports of the County Councillors

The Chairman welcomed County Councillor P. May to the meeting and invited him to give his report which included the following matters.

- 1) Re the possibility of a speed visor for the area, the County Council and the Police had now identified suitable sites. A cost analysis was now awaited.
- 2) The County Council was proposing to re-site certain speed limit signs on North Road. An initial consultation was being undertaken before a decision was taken to proceed or not. If the project was to progress further, a formal consultation would be carried out. Cllr. Noble-Nesbitt considered that it would be important for road users, as well as local residents, to be included in the formal consultation, should the project develop to one.
- 3) Flowers had now been planted in the beds at Northlands roundabout, and Councillors agreed that these looked very attractive. County Cllr. May was now investigating the possibility of having an electricity supply installed on the roundabout.
- 4) County Cllr. May advised that a boundary review was to be undertaken for MP's constituencies. Nationally there were to be fifty fewer MP's, and reviews were to be carried out every five years. The Chairman thanked County Councillor May for his report.

Item 4. 11/83 Adoption of Minutes of Meeting

The Minutes of the Meeting of the Parish Council held on Tuesday 21st June 2011, draft copies of which had been previously circulated, were adopted as a true and accurate record of the Meeting and were duly signed by the Chairman.

Item 5. 11/84 Matters Arising

- a) Re Minute 11/65 section 6). Re two properties with derelict cars in the gardens, County Cllr. P. May advised that the County Council had set up a team to engage with owners whose properties gave cause for concern.
- **b)** Re Minute 11/65 section 7). Re Park View Lower School trees overhanging into a resident's garden, Cllr. Mrs. Caygill had advised the Clerk that it had been ascertained that the trees were not, in fact, overhanging although they were restricting light into the property. Although, therefore, there was no obligation on the School, Cllr. Mrs. Caygill had asked the School to still consider cutting back the trees as a gesture of good faith.
- c) Re Minute 11/65 section 9). Re consultation on the County Durham Plan, the Chairman advised that the Parish Council's sub-group, set up to consider this matter, had met and had agreed a submission which had been sent to the County Council (Appendix 2, attached).
- **d)** Re Minute 11/67 section e). Re the poor appearance of utility boxes, the Clerk advised that the County Council had been in contact with BT who were inspecting 2 boxes under their case reference no. 4153535.
- **e)** Re Minute 11/79 section 2). Re the poor appearance of electricity sub-stations, the Clerk advised that the County Council had been in contact with CE Electric who had agreed to inspect the Leander Avenue sub-station under their case reference no. 779049.
- f) Re Minute 11/68 section 7j). The Chairman advised she had attended the public art work event at Northlands play area. It had been an enjoyable event, also attended by many children.
- **g)** Re Minute 11/69 section d). Councillors had observed that the road surface at the Vigo Lane/Barley Mow roundabout junction was in poor condition. The Clerk will advise this to the Highways Action Line.
- h) Re Minute 11/69 section e). Cllr. Mrs. Forrester advised that the Youth Centre was now closed and a decision on the future of the building would be taken in September by the County Council.
- i) Re Minute 11/71. Re a submission to the Boundary Commission's further draft recommendations, Cllr. Noble-Nesbitt had prepared a draft which was considered and agreed by Councillors (Appendix 3, attached). Residents were urged to send their own short submission in support of the Parish Council.
- (**Resolved** that Cllr. Noble-Nesbitt is to make the agreed submission on behalf of the Parish Council).
- The Chairman thanked Cllr. Noble-Nesbitt for his further work on this matter.
- j) Re Minute 11/79 section 1). Re the tidying of the pond area between Low Flatts and the Drum Industrial Estate, Cllr. Mrs. Caygill had advised the Clerk that she had made contact with the owners of the Estate. A community project had been suggested and Cllr. Mrs. Caygill, with the help of County Cllr. P. May, would be pursuing this. The County Councillor suggested that, in view of the litter and debris at the pond, this was a matter in which the Neighbourhood Wardens could become involved and the Clerk will therefore contact the Wardens.

Councillors discussed this matter and agreed that provision of a polling place in Picktree Village would be well received by residents there. The Clerk will advise the County Council accordingly.

The Clerk advised that the email contained a design proposal for the play area artwork, and comments were requested by Friday 22nd July. Councillors considered that this timescale was too short for a full consideration of the design which had now reached a critical stage, and it would be appropriate for a meeting to be held by the project committee to give the proposal the consideration it deserved. The Clerk will advise the project officer accordingly.

 - e) Approval for internal alterations to include provision of new male and female toilets, hot water heating system and replacement of electrical services, at Lambton Castle.
 - f) Refusal for removal of lower limb of one oak tree, lift of one oak tree, fell to ground level of one sycamore and one conifer and works to various conifers all protected by a tree preservation order, at 20 North Lodge.

Item 7. 11/86 Portfolio Holders' Reports

- a) <u>Play Areas</u> Cllr. Mrs. Caygill had advised the Clerk that there were no matters to report on. The Chairman invited Cllr. Mrs. Walton to give her report.
- b) <u>Horticulture</u> Cllr. Mrs. Walton reported on the matters contained in her written report attached (Appendix 4). Re item 1 of the report, Councillors thanked Cllrs. Mrs. Walton and Mrs. Prest for doing so much work themselves during the absence of a gardener. Re item 2 of the report, Councillors agreed to keep in mind the possible need to source a replacement for the yew tree. Re item 4 of the report, Councillors agreed to keep this in mind for when a new gardener had been appointed.

The Chairman thanked Cllr. Mrs. Walton for her report.

- c) Finance In the absence of Cllr. Jukes, no report was made.
- The Chairman invited Cllr. Mrs. Forrester to give her report.
- d) <u>Publicity</u> Cllr. Mrs. Forrester expressed thanks to Mrs. Noble-Nesbitt who had given much of her time in the preparation of the Newsletter.

The Chairman thanked Cllr. Mrs. Forrester for her report and invited Cllr. Noble-Nesbitt to give his report.

- e) <u>Highways</u> Cllr. Noble-Nesbitt outlined the County Council's proposal to re-site certain speed limit signs on North Road to gain increased compliance of the limits by motorists. Councillors discussed the proposal and agreed that the proposed re-siting was unnecessary as the desired improved compliance could be achieved by simply cutting back branches which were partially masking one of the signs. In addition, the proposed new site would have the effect of extending the 40mph speed limit area which was undesirable. The Clerk will advise the County Council accordingly. The Chairman thanked Cllr. Noble-Nesbitt for his report.
- f) Planning In the absence of Cllr. Tones, no report was made.
- g) <u>Website</u> In the absence of Cllr. Prof. McEwan, Cllr. Noble-Nesbitt advised that the website would be in a position to go live in September. Councillors agreed to discuss this matter at the September meeting of the Parish Council.

The Chairman thanked Cllr. Noble-Nesbitt for his report.
