Minutes of the Meeting of North Lodge Parish Council held at Arizona Chemical, Vigo Lane, Chester-le-Street on Tuesday 18<sup>th</sup> March 2014.

The meeting commenced at 6.30pm with the Chairman welcoming everyone.

## Item 1. 14/24 Apologies for Absence

Apologies for Absence were received from Councillors Mrs. L. LeDune and Mrs. D. Prest.

## Item 2. 14/25 Declarations of Interest

Councillor Mrs. Forrester declared an interest in a matter relating to the ownership of land at Queensmere.

## Item 3. 14/26 Report of the Police

The Chairman welcomed PCSO's Amy Fleetham and Brian Donnelly to the meeting and invited them to give their report. PCSO Fleetham reported on the matters contained in the written report attached (Appendix 1). In addition, the Officers advised that, at present, there were extra patrols in the Lombard Drive area and that two arrests had been made in Park Road North for suspicious behaviour. PCSO Donnelly advised of a current telephone scam involving a false message that a relative was in distress. The Police Office in Newcastle Road was at present being re-furbished. The Chairman thanked the Officers for their report.

## Item 4. 14/27 Report of the County Councillor

The Chairman welcomed County Councillor P. May to the meeting and invited him to give his report which included the matters contained in his written report attached (Appendix 2). Re criminal activity, Cllr. Alderson suggested that the Neigbourhood Watch scheme could be re-vitalised. The Clerk will contact PCSO L. Hunter to propose this. Re capital works, the County Cllr. will enquire if the road surface at the east end of Lombard Drive is to be re-surfaced and if damaged sections of Picktree Lane will be attended to.

The Chairman thanked County Councillor May for his report.

## Item 5. 14/28 Adoption of Minutes of Meeting

The Minutes of the Meeting of the Parish Council held on Tuesday 18<sup>th</sup> February 2014, draft copies of which had been previously circulated, were adopted as a true and accurate record of the Meeting and were duly signed by the Chairman.

## Item 6. 14/29 Chairman's Report

Regarding outstanding matters -

- a) Re Minute 14/14. Re the non-attendance of the Police at the February meeting, the Chairman had contacted Sgt. Paul Teare who had apologized for the omission.
- b) Re Minute 14/15. Re Park View Academy, Cllr. Mrs. Caygill advised that the Academy was considering how to accommodate meetings of local community groups.
- c) Re Minute 14/18 section a). The Clerk will contact the County Council to enquire when the recently installed seat at Merlin Drive play area will be re-sited.
- d) Re Minute 14/18 section b). Re the pond area at Drum Industrial Estate, there had been no further contact from the land agent. Councillors agreed, therefore, that Cllr. Mrs. Caygill should approach the Co-op to ask if they would tidy the path alongside its warehouse.
- e) Re Minute 14/21 section 1). Searches at the Land Registry had established that the land between Queensmere and North Road was owned by some residents of Queensmere. Councillors agreed to consider the appearance of the land in relation to other gardens throughout the Parish. County Cllr. May was concerned that one of the tees on the land might be dead or dying.

The Chairman reported on the matters contained in her written report attached (Appendix 3). Re a raised bed for Barley Mow, Councillors agreed that it could be of the same design as the existing beds on North Road.

Councillors thanked the Chairman for her report.

## Item 7. 14/30 Portfolio Holders' Reports

The Chairman invited Cllr. Mrs. Caygill to give her report.

a) Play Areas Cllr. Mrs. Caygill's report included the following matters.

For Merlin Drive, the recently installed seat awaited re-siting. For Low Flatts, the replacement swing had not yet been installed by the County Council. The Neighbourhood Wardens had still not yet installed a dog fouling warning sign. Cllr. Mrs. Caygill and the Chairman were to attend a forthcoming County Council consultation meeting re fixed play provision.

The Chairman thanked Cllr. Mrs. Caygill for her report and invited Cllr. Noble-Nesbitt to give his report.

## b) Highways and Website

Cllr. Noble-Nesbitt's report included the following matters.

- 1) Streetlight no. 441 at Picktree Lodge was lit continuously. The Clerk will advise this to the County Council. 2) Re the roadworks at Northlands roundabout, no problems had been reported.
- 3) An overgrowing hedge at Lombard Drive had been attended to. 4) A collapsed pavement at Lombard Drive had been repaired. 5) Flower tubs in Merlin Drive had been moved back from the road edge. 6). The website was working well.

The Chairman thanked Cllr. Noble-Nesbitt for his report and invited Cllr. Mrs. Walton to give her report.

c) <u>Horticulture</u> Cllr. Mrs. Walton's report included the matters contained in her written report attached (Appendix 4).

Councillors discussed the planting of flower beds by the County Council and agreed that this should continue for this year with further consideration being given for the future. Re damage to daffodils, Cllr. Mrs. Caygill had taken up the matter with Park View Academy.

# North Lodge Parish Council Report March 2014 From County Councillor Peter May

#### **Council Tax increase**

## Steps to North Road

Completed and looks good

## **Drainage works to reduce flooding on North Road.**

This will involve a little diversion works downstream at the junction of Lombard Drive and an overflow chamber opposite North Lodge. The entrance to North Lodge will be lifted by just under 100mm to stop water flowing down road. Works will be carried out after April.

#### **Railway Station**

The Community Economic Development Team (Central and East) in partnership with the Local Transport Plan Team has successfully secured funds to undertake a number of improvements aimed at revitalising the routes into Chester-Le-Street from the Railway Station into the Town Centre to create a more positive impression for visitors leaving the Railway Station and encourage them to go into the Town Centre; by enhancing the visual appearance of the approach down from the Station into Front Street . The works are due to **commence on 17**<sup>th</sup> **February 2014** starting with the entrance adjacent to St John Ambulance building and will be finishing with works to the Railway Station car park. While the car park works are being undertaken customers will not be able to leave their vehicle at the Station itself and will have to park elsewhere within Chester-Le-Street.

## The proposed works that will be undertaken around the Railway Station are:

#### 1. Station Road entrance adjacent St John Ambulance building

- a. Installation of two new bollards,
- b. Replace grassed area with new foot path and
- c. Replace flags and resurface existing foot path.

#### 2. Under the bridge in Station road/Avondale Terrace

- a. Install new bollards with reflective banding.
- b. New finger post and signs directing pedestrians into the Railway Station and the Town Centre.
- c. Install two new gullies to improve drainage.
- d. Replace the foot path under the bridge with new herringbone pattern bricks.

#### 3. Railway Station car park

- a. Resurface the car park and mark out parking bays on DCC owned land.
- b. Differentiation between DCC owned land and Network Rails land will be made within the car park area (as per the request of Network Rail).
- c. Installation of bollard.
- d. Installation of cycle rack and new finger post.
- e. Repairs to existing foot path.

#### 4. Station Road leading away from the Railway Station

- a. Replace the existing fence and handrail with a new black powder coated fence (refer to examples images below).
- b. Replace existing foot path with a new bituminous foot path.
- c. At mini round about install a pedestrian guard rail.
- 5. New finger post and sign to be installed in Osborne Road directing pedestrians either into the Town Centre or into the Railway Station.

I have been in touch with Police Sgt Paul Teare (Chester le Street) who has sent me information about a rapid deployment and redeployable streetscene system

### **Garden Waste collections**

#### **Dangerous Pavements.**

I have requested that the County Council inspects the pavement between Northlands Roundabout and Camperdown Avenue. (Along Park Road North) Tree roots are raising the tarmac in many places causing a danger to pedestrians. Inspection cover North Road.

On North Road on the pavement near pedestrian refuge Longdene park junction area. What looks like along inspection hatch is standing proud of the pavement.

Pedestrians are at risk of tripping and so please can you arrange for it to be repaired. Will be repaired within next week

## Extra £140m to help councils repair 'most damaged' roads

#### AAP IMPROVEMENTS.

Along with many other residents I am concerned that the AAP is losing its focus and is not reporting at its Board Meetings, subjects that interest local residents. This is due to be discussed at a special meeting 31 March but unfortunately I cannot attend. I have therefor sent this memo to Andrew Megginson for consideration:

As you are aware I will be on holiday and regrettably will be unable to attend the meeting.

May I say from the outset that I appreciate the amount of hard work and preparation that you and your team applies to our AAP activities and the following comments are not a criticism of anyone - but situations evolve and change is often needed in order to survive

During the last Board meeting I was supportive of the member of the public (Peter Usher) who gave constructive criticism of the way that Board meetings were held (content wise). I have for some while now held similar views and it is noticeable that public attendance at Board Meetings appears to be decreasing.

I would like to make the following comments in the hope that they might feature in the discussions at the Board Development Session:

- What exactly is the purpose of having an AAP? I believe that it should represent the views and aspirations of the local community and provide **meaningful and interesting feedback** to its community.
- Whilst I appreciate that currently Board Meetings are supposed to be for "The Board" to make decisions on AAP direction etc. we are now in danger of these meetings becoming BORD MEETINGS for members of the public and Board Members alike. Similar issues appear to be discussed time after time often with no specific reference to Chester Le Street and District.
- Most of the interesting topics for residents are discussed at the smaller committee meetings such as Environment or Town and Villages etc. but hardly any time is given to updating either The Board or public at a Board Meeting.
- I would like to see on the agenda a time allocated to the Chairs of each committee to enable them to give a brief report of their activities.
- The public also should be allowed time to ask questions of The Board or to make comments relating to Committee activities.
- We should also ensure that the public is informed about County Council initiatives and how to access them if applicable e.g. ongoing consultations **how will they affect our area specifically**

Generally we need to be more user friendly and local. Perhaps the term Board Meetings should be renamed as Community Update Meetings
