Minutes of the Meeting of North Lodge Parish Council held at Arizona Chemical, Vigo Lane, Chester-le-Street on Tuesday 20th January 2015.

The meeting commenced at 6.30pm with the Chairman wishing everyone a Happy New Year.

Item 1. 15/01 Apologies for Absence

Apologies for Absence were received from Councillor Dr. D. Hartley.

Item 2. 15/02 Co-option of Councillor

The Chairman welcomed Dennis Hall to the meeting.

(Resolved - to co-opt Mr. Dennis Hall as a Parish Councillor).

Item 3. 15/03 Declarations of Interest

Cllr. Mrs. Caygill declared an interest as a Governor of Park View School.

Item 4. 15/04 Report of the Police

The Police were not present at the meeting but had provided a written report (Appendix 1, attached) and this was read out by the Clerk.

Item 5. 15/05 Report of the County Councillor

The Chairman invited County Councillor P. May to give his report which included the following matters and began with the County Cllr. wishing everyone a Happy New Year.

- a) The County Cllr. outlined the "It's Your Neighbourhood" fund available to community groups.
- b) The County Council was seeking to implement a 20mph speed limit outside all schools in the County although probably not in Lombard Drive.
- c) The County Cllr. had dealt with residents complaints re street lighting.
- d) The County Council had been asked to consider additional street lighting in Longdean Park.
- e) The County Council needed to make additional savings of £16.3M for 2015 / 2016.
- f) The County Cllr. outlined a planning application at 1 Park View.
- g) Fly-tipping had increased by 37% year on year. The County Council had introduced a campaign to tackle this problem.
- h) The County Council was reviewing play provision throughout the County. However, in Chester-le-Street, all play provision would continue to be supported.
- i) At the recent Residents' Association meeting, some in attendance there had complained that there was no representative from the Parish Council. Councillors discussed this and were surprised at the comment, given that it was the first time in memory that there had not been a Parish Councillor at a Residents' Association meeting. Although attendance will resume, there are other well-established channels for anyone wishing to contact the Parish Council at any time.

The Chairman thanked the County Councillor for his report.

Item 6. 15/06 Adoption of Minutes of Meeting

The Minutes of the Meeting of the Parish Council held on Tuesday 18th November 2014, draft copies of which had been previously circulated, were adopted as a true and accurate record of the Meeting and were duly signed by the Chairman.

Item 7. 15/07 Chairman's Report

- a) Re Minute 14/119 section a). Re the Drum pond project, the Clerk will pursue the land ownership issue.
- b) Re Minute 14/119 section b). Cllr. Mrs. Walton advised that she had been unable to locate the plaque for the millennium yew tree. Councillors agreed that a replacement should be purchased.
- c) Re Minute 14/120 section a). Re dog fouling signs and bins for the Picktree Lodge area, Cllr. Noble-Nesbitt and the County Cllr. agreed to liaise in making a new request to the County Council.
- d) Re Minute 14/120 section 7c1). Re a possible community room at Park View School, Cllr. Mrs. Caygill advised that the difficulties of cost and disruption to the school in removing the asbestos there has put the project on hold indefinitely. Cllr. Mrs. Caygill will, however, continue to press for a facility at the School.
- e) Re Minute 14/120 section f). Cllr. J. Waugh kindly offered to take up the vacant Finance Portfolio post. Councillors accepted the offer and thanked Cllr. Waugh.

The Chairman reported on the matters contained in her written report attached (Appendix 2). Re Northumbria in Bloom, the Chairman is shortly to meet with the Civic Pride team to discuss the Barley Mow roundabout area.

Councillors thanked the Chairman for her report.

Item 8. 15/08 Portfolio Holders' Reports

The Chairman invited Cllr. Noble-Nesbitt to give his report.

a) Highways and Website

Cllr. Noble-Nesbitt's report included the matters contained in his written report attached (Appendix 3).

The Chairman thanked Cllr. Noble-Nesbitt for his report and invited Cllr. Mrs. Walton to give her report.

b) Horticulture

Cllr. Mrs. Walton's report included the matters contained in her written report attached (Appendix 4). Cllr. Noble-Nesbitt reminded Councillors that the willow tree in Lombard Drive is to be moved to Merlin Drive play area. Cllr. Mrs. Caygill suggested that this could be done in conjunction with planting of shrubs to fill the gap in the hedge at Low Flatts play area. County Cllr. May advised that he hoped to hold a front gardens competition and also to arrange a walk around the Ward. Cllr. Mrs. Caygill suggested that a boundary walk should be arranged.

The Chairman thanked Cllr. Mrs. Walton for her report and invited Cllr. Mrs. May to give her report.

c) Publicity

Cllr. Mrs. May advised that there were no matters to report.

At Low Flatts

5) Sustrans intended to create a wildflower garden near to the footbridge over the railway.

At Merlin Drive

6) The play area had been inspected and everything was in order.

The Chairman thanked Cllr. Mrs. Caygill for her report and invited Cllr. Snaith to give his report.

Cllr. Snaith advised that there were no matters to report.

The Chairman thanked Cllr. Snaith.

It was agreed to maintain the precept at an amount of £19.35 Band D equivalent per household per annum. Including the LCTRS grant of £623.00, this will provide an income of £17, 999.30. (**Resolved** - to set a Precept for 2015 / 2016 of £19.35 per Band D equivalent household).

In the absence of Cllr. Dr. Hartley, who was to give a presentation on this matter, this item will be

<u>Item 12. 15/12 Transparency Code</u>

The Clerk outlined the new Code which is intended to be introduced to replace the present Audit regime. The Government intends to provide support to assist with the introduction of the new Code and details of this support are awaited.

The Clerk outlined the new Scheme which has replaced the Quality Council scheme. Councillors agreed to keep the Scheme in view whilst making progress towards an application for Foundation status.

Highways report for the NLPC meeting of 20 January 2015

The incomplete Leander Avenue remedial patching appears to be on a DCC listing for future work.

DCC has taken action to rectify the tripping hazard between lamp standards 20 and 22 on North Road.

A dog waste bin and 'Dog fouling' notices remain as priorities for Picktree Lodge, as described in the November report.

Northlands Roundabout new layout – comments coming my way continue to be very positive indeed about the new system as a whole. Because the traffic lights cause traffic to move north in 'batches' along North Road, the gaps created allow for the easier emerging of traffic from Lombard Drive when turning right. There may be similar positive effects that can be observed on the roads radiating from the roundabout.

The rebuilding of the North Road bus stop shelter appears to be substantially completed.

The Junction 63 roundabout alterations are at a stage where the temporary signs indicating the lane to be taken for the southbound A1 contradict the markings on the road surface for traffic emerging from Blind Lane, for example.
