Minutes of the Meeting of North Lodge Parish Council held at Arizona Chemical, Vigo Lane, Chester-le-Street on Tuesday 21st April 2015.

The meeting commenced at 6.30pm with the Chairman welcoming everyone. Councillor Mrs. M. May and County Councillor P. May were not present at the start of the meeting.

Item 1. 15/42 Apologies for Absence

Apologies for Absence were received from Councillors Dr. D. Hartley, N. Alderson and J. Waugh. Cllr. Alderson had indicated his intention to deliver a letter of resignation at the end of the month.

Item 2. 15/43 Declarations of Interest

Cllr. Mrs. Caygill declared an interest as a Governor of Park View School.

Item 3. 15/44 Report of the Police

The Police were not present at the meeting but had provided a written report (Appendix 1, attached) and this was read out by the Clerk.

As the County Councillor was not present at this point, Agenda item 4 was deferred.

Item 5. 15/45 Adoption of Minutes of Meeting

The Minutes of the Meeting of the Parish Council held on Tuesday 17th March 2015, draft copies of which had been previously circulated, were adopted as a true and accurate record of the Meeting and were duly signed by the Chairman.

At this point, Cllr. Mrs. M. May arrived at the meeting.

Item 6. 15/46 Chairman's Report

- a) Re Minute 15/35 section b1). Re fly-tipping on the Sustrans cyclepath, the Clerk advised that the County Council would consider use of a covert camera if the problem persisted.
- b) Re Minute 15/35 section c). Re molehills at Merlin Drive play area, the Clerk will again contact the County Council.
- c) Re Minute 15/35 section f). Councillors thanked Cllr. Snaith for the informative written report he had provided to the March meeting of the Council.
- d) Re Minute 15/41. Cllr. Mrs. Caygill advised that the recently planted trees in Low Flatts Road had now been re-sited with the agreement of residents there. The Clerk advised that the County Council did not have a protocol for consultations with residents for small projects.

The Chairman reported on the matters contained in her written report attached (Appendix 2). Councillors thanked the Chairman for her report.

At this point, County Councillor P. May arrived at the meeting.

Item 4. 15/47 Report of the County Councillor

The Chairman invited County Councillor P. May to give his report which included the matters contained in his written report attached (Appendix 3).

County Cllr. May will also follow up with the County Council the request for additional dog bins and attention to signage at Picktree Lodge.

Cllr. Noble-Nesbitt asked the County Cllr. to request that the Neighbourhood Wardens give attention to properties in the Parish that had overhanging hedges.

The Chairman thanked the County Councillor for his report.

Item 7. 15/48 Portfolio Holders' Reports

The Chairman invited Cllr. Mrs. Walton to give her report.

a) Horticulture

Cllr. Mrs. Walton's report included the matters contained in her written report attached (Appendix 4). Cllr. Mrs. May then presented a Flower Beds summary (Appendix 5, attached). Councillors discussed this proposal and agreed that it should be implemented as presented. The Clerk will advise the County Council who will maintain the beds on behalf of the Parish Council. (Resolved - to implement the flower beds proposal, as presented).

The Clerk will also carry out a Land Registry search re the land between the two fences at the former BOC site at Barley Mow.

Cllr. Mrs. May advised that the Lambton Park Property Owners Association had £24 remaining from a horticulture project at the entrance to Lambton Park, and wished to donate this to the Parish Council. Councillors accepted this donation with thanks and agreed that the money should be spent on additional plants for the Lambton Park entrance.

The Chairman thanked Cllrs. Mrs. Walton and Mrs. May, and invited Cllr. Noble-Nesbitt to give his report.

b) Highways and Website

Cllr. Noble-Nesbitt advised that the website was satisfactory. The only highways matter (dog bins and signage) had been dealt with earlier in the meeting.

The Chairman thanked Cllr. Noble-Nesbitt for his report and invited Cllr. Mrs. Caygill to give her report which included the following matters.

c) Play Areas

At Low Flatts, there were weeds needing to be cut back at the small gap in the hedge. Cllr. Mrs. Walton is to consult the Gardener re filling the gap with cuttings. At Merlin Drive, a faulty piece of equipment had been reported to the County Council who were taking appropriate action.

The Chairman thanked Cllr. Mrs. Caygill for her report and invited Cllr. Mrs. May to give her report.

d) Publicity

Cllr. Mrs. May advised that, as preparation of the Newsletter was on the Agenda, there was nothing further to report at this point.

The Chairman thanked Cllr. Mrs. May and invited Cllr. Snaith to give his report.

e) Planning

Cllr. Snaith reported on a recent Neighbourhood Plans meeting attended by the Chairman,

Cllr. Mrs. May and himself. Councillors discussed the need for a Plan for the Parish and agreed that it would be necessary to hold a supplementary meeting to move this forward.

The Chairman thanked Cllr. Snaith for his report.

Item 9. 15/50 Financing of Projects

Councillors discussed several projects, in addition to the Flower Beds project discussed earlier, that had been presented for funding consideration.

a) Cllr. Mrs. Caygill gave an up-date re the proposed community room at Park View School. The Parish Council was being asked to contribute £3987.78 + vat towards the conversion work to create a room which would be available to community groups for hire out of school hours. However, in recognition of the Council's financial contribution, the Council would receive use of the room for free, up to 12 times per year. Concerns re asbestos in the building had now been answered satisfactorily.

(Resolved on a unanimous show of hands - to contribute £3987.78 to the community room project at Park View School).

Thanks were due to Cllrs. Hall and Waugh for their work on specific matters of the project.

- b) Cllr. Mrs. Caygill outlined a Park View School project to create 4 pieces of sculpture. Councillors discussed this and agreed that, in view of the funding requirements of other current projects, no contribution could be made to the sculpture project.
- c) Councillors again discussed the possibility of welcome signs at the Parish entrances of Barley Mow and Northlands. The Clerk is to contact the County Council to ascertain if any types of signs would be acceptable.

Item 10. 15/51 The Newsletter

Cllr. Noble-Nesbitt advised that he and his wife would again be willing to help in the production of the Newsletter. Councillors expressed their gratitude for his offer. Various items were suggested for inclusion in the Newsletter for forwarding to, and consideration by, Cllr. Noble-Nesbitt.
