Minutes of the Meeting of North Lodge Parish Council held at Park View School, Lombard Drive, Chester-le-Street on Tuesday 15th September 2015.

The meeting commenced at 6.30pm with the Chairman welcoming everyone.

Item 1. 15/94 Apologies for Absence

Apologies for Absence were received from Councillor Mrs. M. May and County Councillor P. May. The Chairman advised that Councillor Dr. D. Hartley had tendered her resignation from the Council. The Clerk is to write to Dr. Hartley expressing thanks for her service to the Parish. The Clerk will advertise the new vacancy.

Item 2. 15/95 Declarations of Interest

Cllr. Mrs. Caygill declared an interest as a Governor of Park View School.

Item 3. 15/96 Co-option of Councillor

Councillors discussed the interest expressed by Jackie Martin, a resident of the Parish, in filling the vacancy created by the resignation of a Councillor in May 2015.

It was proposed by Cllr. Noble-Nesbitt and seconded by Cllr. Mrs. Caygill that Jackie Martin be offered a seat on the Council. The proposal was carried unanimously. The Clerk will contact the resident accordingly.

(Resolved - to offer to Jackie Martin a seat on the Council).

Item 4. 15/97 Report of the County Councillor

In the absence of the County Councillor, a written report (Appendix 1, attached) had been provided and this was read out by Cllr. Mrs. Forrester.

Item 5. 15/98 Adoption of Minutes of Meeting

The Minutes of the Meeting of the Parish Council held on Tuesday 21st July 2015, draft copies of which had been previously circulated, were adopted as a true and accurate record of the Meeting and were duly signed by the Chairman.

Item 6. 15/99 Chairman's Report

a) Re Minute 15/86. The replacement seat for Low Flatts play area had not yet been installed. The Clerk will again remind the County Council.

b) Re Minute 15/88 section a). Re parking at Lombard Drive, it appeared that vehicles were being left there all day whilst the drivers were at work elsewhere. At school leaving time in particular, but also throughout the day, this was causing difficulties for other traffic entering or leaving Lombard Drive at the North Road junction. The Clerk is to contact the County Council to seek a solution to the problem.

c) Re Minute 15/89 section c). Cllr. Mrs. Caygill advised that the Co-op Environment Team had again done an excellent job in clearing the footpath from Low Flatts to Drum Industrial Estate. The Clerk is to express thanks to the Co-op and an item is to be included in next year's Newsletter. The Clerk was thanked for taking away the bags of rubbish collected by the Team. Cllr. Mrs. Caygill and the Clerk will liaise in the submission of an article to the local newspaper.

d) Re Minute 15/93 section b). The Clerk advised that the County Council had declined to provide a waste bin for the Drum pond area because 1) the land is privately owned, 2) the County Council does not have any available manpower to service any additional bins.

e) The Chairman advised that he now had an email address. He had attended the recent Residents' Association meeting and had given a report on behalf of the Parish Council.

Item 7. 15/100 Portfolio Holders' Reports

The Chairman invited Cllr. Waugh to give his report which included the following matters. a) Finance

Cllr. Waugh gave an up-date (Appendix 2, attached) of bank balances held by the Parish Council. The Clerk had prepared a grant application to the County Association for £346 towards the cost of implementing the Transparency Code for Smaller Authorities, and submission of the grant was approved by Councillors.

(**Resolved** - to submit a grant application for £346 in respect of the Transparency Code). The Chairman thanked Cllr. Waugh and invited Cllr. Noble-Nesbitt to give his report.

b) Highways and Website

Cllr. Noble-Nesbitt's report included the following matters.

1) Following distribution of the Newsletter containing a request to residents to cut back overhanging hedges, several hedges had been attended to.

2) A footpath in the Caxton Way/Sustrans cycleway area required clearing of leaves. The Clerk will advise the County Council.

3) Cllr. Mrs. Caygill advised that she had asked the County Councillor to look into a matter regarding tall trees blocking out light in the Leander Avenue/Bafflebank area. A response was awaited.

4) Cllr. Mrs. Caygill advised that the County Council had carried out some temporary patching of the road at the south end of Lyndhurst Avenue, prior to the road being inspected by the Highways Inspector next month with a view to a more substantial repair.

5) Cllr. Waugh advised that there was graffiti on the motorway side of the fence between Lambton Park estate and the motorway. The Clerk will advise Highways England accordingly.

The Chairman thanked Cllr. Noble-Nesbitt and invited Cllr. Mrs. Walton to give her report. c) Horticulture

Cllr. Mrs. Walton's report included the matters contained in her written report attached (Appendix 3). Cllr. Mrs. Caygill reminded Councillors that the willow tree near the entrance to Lombard Drive was due to be moved to Merlin Drive play area. However, with several trees there dying recently, Councillors now considered that the willow tree should remain at its present site.

The Chairman thanked Cllr. Mrs. Walton for her report and invited Cllr. Mrs. Caygill to give her report.

d) Play Areas

Cllr. Mrs. Caygill's report included the following matters.

1) At Low Flatts, all equipment was in good order and being well used.

2) The Clerk had received a report of a car being driven round the grassed area and this had been passed on to the Police.

. 3) Concern had been expressed regarding the condition of horses in a field next to the play area. The Police had been advised.

4) At Merlin Drive, a damaged item of equipment had been attended to by the County Council.

5) The County Council had advised that there were no more recent signs available than were

already at the play area except that "No Smoking" signs would soon be installed.

6) Cllr. Noble-Nesbitt proposed that an item of adult exercise equipment should be considered for installation. Cllr. Mrs. Caygill is to enquire about prices.

The Chairman thanked Cllr. Mrs. Caygill.

e) <u>Planning</u>

Cllr. Snaith's report included the following matters.

1) Negotiations were still ongoing re the County Durham Plan.

2) Cllr. Snaith had obtained an assurance that the Parish Council would be included in consultations regarding the former BOC site.

3) Cllr. Mrs. LeDune raised a concern regarding the development of the Drum Lane Traveller's site. Cllr. Snaith will enquire if planning conditions/approvals are up-to-date.

Councillors thanked Cllr. Snaith for his report.

The Chairman invited Cllr. Mrs. Forrester to give her report.

There have been no County Council meetings during August and very few during July.

• Chester-le-Street Town In Bloom have been invited to attend the Northumbria In Bloom Awards which take place in Berwick this year. visit cancelled due to lack of interest by AAP members in the Environmental task group. Myself as Vice Chair and Parish Councillor Maureen May volunteered to go but apparently this was not a viable proposition economically for transport.

Employment in Chester Le Street

• In 2000 we had 385 full time and 155 part timers (77 whole time equivalents) employed by DCC. Now we have 6 in the Front Street Office. The Independents Group are bringing this to the attention of the Council

Have asked for the footpath between Picktree Village and motorway to be cleared of overhanging shrubs etc.

Picktree Village Reported collapsing wall belonging to Lambton Estates who have been asked to repair it.

Fly tipping – Fatfield Harraton Terrace Lambton Park.

• Durham County Council own a small area of woodland accessed via a small lane at Harraton Washington. Local Sunderland Councillors have complained that DCC have not taken fly tipping reports seriously when reported.

I organised a meeting 07/08/2015 at the site with Oliver Sherratt, Martin Briscoe, Cllr Tony Taylor Sunderland and Sunderland Officers.

We toured site and were shown fly tipping sites and agreed to monitor the area with warden visits and cameras. Ideally this area should be taken over by Sunderland. There is still fly tipping and some people have been caught.

Awaiting formal report from Martin on DCC activity.
