Minutes of the Meeting of North Lodge Parish Council held at Park View School, Lombard Drive, Chester-le-Street on Tuesday 15th November 2022.

The Chairman welcomed everyone to the meeting.

Item 1. 22/103 Apologies for Absence

Apologies for Absence were received from Councillor Chris Veitch.

Item 2. 22/104 Declarations of Interest

Councillor Craig Martin declared interests as a County Councillor and as a Governor of Park View Academy.

Item 3. 22/105 Report of the County Councillor

The Chairman invited the County Councillor to give his report which included the matters contained in his written report below -

Defibrillator at Wheatsheaf

I've funded the installation of a defib at the Wheatsheaf. This is being done through the North Lodge Remembrance Group.

Those running the Wheatsheaf have kindly agreed to have the device attached to the pub. They will also fund the electricity required to keep the defib heated.

Both pubs now have a public defib that can be accessed 24 hours a day by calling 999. I look forward to working with the parish council to see how I can assist in installing more of these devices across the area.

North East Devolution Deal

Durham County Council are seeking to form a devolution deal with Gateshead, Newcastle, North Tyneside, Northumberland, South Tyneside, and Sunderland. The deal will provide additional funding from government, which will be spent through an elected mayor.

I personally believe that the devolution process that the government are setting out is flawed. But have approached this decision wanting the most democratically accountable option and one that gives us the most funding. There are two offers on the table, North East region or a County Durham deal.

The North East deal will have zero effect on council services. The combined authority will sit above local authorities controlled by an elected mayor that exists to hand out funding for additional projects. The leaders of all the local authorities will form a cabinet with the mayor, who will have powers to block proposals in their own local authorities. So there is a mandate everyone to work together and form a consensus on projects. This deal is set to have highest amount of funding, per

head of population, than any other devolution deal in the country.

A county deal would see the devolution powers and funding given directly to Durham County Council. Absolutely all of it would be spent within County Durham, but the amount (and the powers given) is considerably less per head of population than a regional deal. An elected mayor would control this funding along with control of all council services.

The reason I'm very much against a county deal is handing all this power to an individual to run all the services is not very democratic. At least with the current system, having a leader of the council, if they start doing ridiculous things councillors can remove them from power. The North East deal is still currently being negotiated with government and a final decision is yet to be made.

Nitrous Oxide Motion

I assisted in a motion to increase restrictions on the sale of Nitrous Oxide (NO) by seconding it. The motion was originally created by the Conservatives and was supported by the council. Those silver canisters of NO can be bought online and delivered to anyone's door, no questions asked. So I was particularly calling for age restrictions on who it could be sold for.

I spoke in particular about the need to take a health based approach in trying to solve this problem. How the war in drugs is just leading users to just turn to other highs as one source is being cut off. Highlighting the fantastic work County Durham Drugs service does in rehabilitating users and educating everyone about the dangers of drug use.

In addition, the County Cllr, in response to a request from Cllr Gregory, will obtain recent pollution data for the Northlands roundabout area.

The Chairman thanked the County Councillor for his report.

d) Highways and Community Assets

The monthly bus shelters inspection was carried out on Monday 7th of November. All appeared in good working order, with leaf clearance, and litter and glass removal, being the main supplementary tasks.

The south bound bus shelter on North Road, near the Lombard Drive entrance, has had the back wall painted to cover the sprayed lettering, and is awaiting another coat of paint to improve the appearance. The bus shelter in North Road, south bound, past the Barley Mow roundabout, has the new glass cabinet installed, with the final commended school art poster displayed.

In addition, Cllr Driscoll advised that the bus shelter near Lombard Drive has now had the back wall re-painted. Cllr Caygill advised that new posters were expected from the School to display in the

noticeboards and display boards.

The Chairman thanked Cllr Driscoll for his report and invited Cllr May to give her report which included the matters contained in her written report below -

e) <u>Horticulture</u>

1. Durham County Issues

a. Ian Harland has informed us that the work on the two large shrub beds in North Road will commence probably at end of November.

- b. Large flower beds have now all been planted up with winter bedding.
- c. Still no further decisions have been made regarding entrance to Picktree Lodge

2. Horticulture Sub Group

a. Tree Planting in Honour of Queen's Canopy

Councillors will meet shortly with Durham County Council Officers - re this subject.

b. Daffodils have been planted around North Lodge Parish:

Merlin Drive play area: by Park View School Student and teacher Melanie, Councillor Caygill, Councillor May, Resident Peter May and assisted by our Parish Gardener Stephen Makepeace.

Also planted at east side of North Road and Northlands Shrub Bed

More areas may be planted in 2023 following the completion of Avant

Homes on Vigo Lane.

c. Bio-Diversity

This subject was discussed briefly. The Group are aware that Bio-Diversity should be considered when planting takes place.

d. Barrels

Four unsafe barrels have been removed by Parish Gardener:

One from Northlands roundabout area and three from Lombard Drive near to Park View School.

Ten Barrels remain - Two close to Northlands Roundabout, two at entrance of North Lodge, Lambton Park and six on west side of North Road.

e. Wheatsheaf Wasteground Area

Sub Group have decided upon a design suggested by Stephen Makepeace which is to clear the area and grass over. This is in keeping with Horticulture on North Road.

3. Report from Parish Gardener Makepeace Landscapes

Please find report November 2022. All areas and bus stops have been kept clean various visits have been carried out to maintain the areas and keep them looking sharp. Bedding plants have now been supplied and fitted giving an array of colour and life to the bed areas. These have been maintained with weeding and hoeing and a watchful eye. Bulb planting was carried out using our bespoke bulb planters which take exactly the right amount of soil from the ground so a bulb can be planted. Then the soil plug fits perfectly over top giving the bulb the best chance and environment to flourish. We carried out some work at the play park taking plugs out for the children to plant bulbs afterwards we returned to make good the areas and keep the play park tidy. We've been calling collecting the many leaves and will keep at it ensuring the areas are kept clear as much as possible. We planted the tubs up alongside the areas to make sure everything is tidy and fresh a few tubs were removed as these were failing and we called recently and removed some metal straps form one tub were they had snapped with rust to remove the risk of anyone hurting or cutting themselves. I hope all is in good order we want only the best and take great pride in our work any feedback is greatly appreciated. Stephen

In addition, Cllr May advised that a price had now been received verbally from Durham County Council for the planting of the flower beds. Councillors agreed that a comparative quote should be sought from Makepeace Landscapes. Cllr Martin suggested that consideration should be given to planting shrubs rather than bedding plants.

h) Play Areas

MERLIN DRIVE

All equipment seems to be in good working order except for a mangled chain on one of the new swings. I have reported it.

Most of this area has been planted with daffodils by Park View pupils, assisted by Coun. May, Mr. May and myself. We were unable to complete the planting due to an under estimation of bulbs in each sack. We will complete next year.

LOW FLATTS

All equipment seems to be in good working order.

No news yet of the refurbishment.

The Chairman thanked Cllr Caygill for her report.

i) Policy and Governance

Cllr Hall's report was contained in his Chairman's Report (Minute 22/107, above). Re online abuse, Councillors agreed that it was necessary to remain careful and vigilant.

Item 8. 22/110 Proposals, Reports and Requests for Consideration

a) Chester-le-Street Masterplan and Deprivation

The Chairman introduced this matter and gave his assessment of the Masterplan. A substantial discussion by Councillors was held and this established that there was a need for further information regarding specific and tangible actions to implement the written plans for the improvement of the retail, marketplace, history and tourism aspects of the town. The County Councillor kindly agreed to take this forward and to report back at the next meeting of the Council.

b) Production of Crime Prevention Leaflets

Cllr Gregory advised that, in conjunction with the Clerk and the Police re appropriate wording, it was expected that a leaflet would be ready for distribution to all households in the Parish at the beginning of December. Councillors gave their agreement to the project.

c) A Commemoration for the Forthcoming Coronation of King Charles III

Cllr Caygill advised that the School would base the next Civic Arts project on the Coronation. Councillors agreed with Cllr Gregory in the hope that Cllr Veitch would again provide silhouettes of a crown in the flower beds and elsewhere. Cllr Waugh reminded Councillors that the Jubilee Badge project had been well received and therefore a similar project could be considered for the Coronation. Other suggestions included a designed seat, a plaque, a paving stone and renaming a play area. Agreed that residents should be asked by social media for their ideas.

d) Budget: Forward Planning

Portfolio Holders were reminded to provide by mid-December, costed proposals for consideration for the 2023/24 budget. Various potential projects were discussed. Cllr Martin advised that there were two projects in development, the Drum Artwork project and the Remembrance Artwork project, that the Council would be asked to contribute to financially although there were no costings available yet.
