

## **NORTH LODGE PARISH COUNCIL**

Minutes of the Meeting of North Lodge Parish Council held at Park View School, Lombard Drive, Chester-le-Street on Tuesday 15<sup>th</sup> July 2025.

The meeting commenced at 6.30pm with the Chairman welcoming everyone, in particular Graham Watson who had applied for co-option to the Council.

Cllr Caygill advised of the recent death of former Councillor Carole Walton. The Clerk is to send a sympathy card.

### **Item 1. 25/82 Apologies for Absence**

Apologies for Absence were received from Councillors Jackie Gregory and Chris Veitch.

### **Item 2. 25/83 Declarations of Interest**

Councillor Craig Martin declared interests as a County Councillor and as a Trustee of Park View Academy.

### **Item 3. 25/84 Application for Co-option - Graham Watson**

Mr Watson had applied to be co-opted to the Council. His application form had been previously circulated by the Clerk to all Councillors. Mr Watson left the meeting whilst Councillors discussed his application which was approved unanimously. Cllr Watson then returned to the meeting and was welcomed to the Council.

### **Item 4. 25/85 Report of the County Councillor**

The County Councillor's report included the matters contained in his written report below -

#### **Park View Ofsted 'Good'**

Park View School's recent Ofsted inspection has come back with 'good' in all areas while its 6<sup>th</sup> form provision is 'outstanding'. This is an improvement from two years ago when the school was rated 'requires improvement'.

This only happened down to the hard work of all the staff, students, and parents. As one of the trustees of the school, I've supported leaders in delivering improvements in the school and challenged them on their work. The last Ofsted inspection has led to a concerted effort to improve standards for all pupils.

Park View School has always been successful at delivering students with high grades. But the work done in improving the grades of students from disadvantaged backgrounds is what led to the improved rating.

### **Consultation County Durham Plan**

The government has increased the housing allocation for County Durham, meaning that the Council now must redo the County Plan. They've opened a consultation calling on stakeholders to put forward initial areas they believe would be good locations to develop. I recommend Parish Councillors take a look at it and participate.

Cllr Hawkes is to liaise with Cllr Veitch for an item on social media. The County Cllr advised that he was already supporting the residents who had raised the matter with him.

##### Fatal Four

##### Drones

Durham Constabulary has expanded its fleet of Drones further and can now operate drones 24/7. With 40 qualified pilots now able to operate the drones, several hubs have been created across County Durham and Darlington, meaning that a drone is only minutes away from an incident if needed.

Durham Police and Crime Commissioner Joy Allen has recently provided funding for 16 new pilots and four drones.

It is hoped further funding will be secured to allow for further training and equipment in the coming months.

##### Illegal Waste Carriers

Neighbourhood Wardens teamed up with officers from Durham Constabulary and the The Driver and Vehicle Standards Agency (DVSA) as part of an operation to crack down on illegal waste carriers.

Wardens checked that correct licences were in place to transport waste, officers from Durham Police and DVSA carried out full inspections on the vehicles to ensure they were fully road legal. These checks are vital in the fight against fly-tipping and environmental crime. If you carry waste as part of your business, make sure you're registered.

Remember: Always ask to see a waste carriers license and ask for a receipt before handing over your rubbish!

#### Independent Co-opted Panel Member

The Durham Police and Crime Panel is looking to appoint an independent co-opted member from County Durham or Darlington who is committed and enthusiastic.

The Police and Crime Commissioner is responsible for setting the priorities and resources for Durham Constabulary, as well as supporting broader community safety activities across the region. They're required to consult with the panel on their plans for budget and policing, as well as the level of tax collected through the Council tax and the appointment of a Chief Constable.

Independent co-opted members, through their knowledge and experience, are expected to enhance the panel's ability to play its role effectively.

**SUMMARY**

The summer flower beds are now flourishing and looking very good. There is one bed of concern in Lombard drive which appears to have been damaged - ? by rabbits or vandalism. The jubilee tree has also been damaged by rabbits. Councillor May has discussed this issue with Stephen Makepeace. Stephen and his team have replaced the jubilee bedding three times. If the Council so wishes, Stephen will replace the plants and charge the Parish Council the cost of the bedding plants but will plant them free of charge. Stephen Makepeace and his team have consistently watered and fed all the beds. Stephen has reported back that he has had several nice comments from the public regarding their work, which he is very proud of.

I asked about trespassers at Picktree farmhouse and he stated that renovation work and securing the boundary will begin soon. Fingers crossed for that. No more ugly graffiti has appeared recently. I have noticed the same signature around Rickleton and around Vigo Lane.
