

Merlin Drive and Low Flatts Play Areas



The two play areas continue to be a real asset to the community, both well used and enjoyed. County Councillor Peter May allocated funding for the replacement seesaw at Merlin Drive, giving a full complement of equipment.

County Durham Plan and Northlands Roundabout Neighbourhood Planning

The Government Independent Inspector's interim view, on the legal compliance and soundness of the County Durham Plan's final version, was published in February 2015. The complete report is very comprehensive and also critical. It includes a recommendation that the proposed developments to the south of the Drum Industrial Estate and in Lambton Park should not

In view of the fact that Durham County Council lodged Judicial Review papers at Leeds High Court in May 2015, and the complexity of the situation as a whole, the Parish Council is waiting to further consider its production of a neighbourhood


The background, detail and chronology to the County Durham Plan can best be followed on the Durham County Council website.

(with origins within the TRANSIT 15 programme)

On-site observations of the final working configuration of this roundabout indicate a consistency with the dynamic computer model that the Parish Council was shown by DCC at the planning stage. There is vastly improved movement of traffic, including buses [without the need for additional bus lanes] and very effective crossing facilities for pedestrians. Feedback from users of the roundabout indicates a remarkably consistent high level of satisfaction with the completed arrangement. As with any changed road system, some users will still experience problems. . .

One of the final steps in the DCC plan was to rebuild North Road (Northlands) bus shelter (at its expense) on behalf of the Parish Council and this has now been completed.

The Parish Council has written to the County Council in support of footpaths from Caxton Way and Merlin Drive towards the motorway baffle bank to become recorded as public rights of way: as such, their future maintenance may be ensured.

PAVEMENT IMPERFECTIONS

Holes or ridges of at least 2 centimetres drop or rise can be reported to the Durham County Council Help Line with help@durham.gov.uk for email and 03000 26 1000 for telephone. Use the number on the nearest lamp standard as a position marker and ask for a help line reference number.

The use of the website "FixMyStreet" remains particularly helpful for pinpointing the position of a problem by using the maps provided. Concerns about roads may be similarly reported.

...and for continuing responsible action

Please check your hedges

...and show consideration by ensuring that your hedges, shrubs and trees do not extend at all beyond your property's boundary with public footpaths, throughout the whole year. Giving clear headroom of about 7 feet 6 inches is also important. This should allow for the safe passage of pedestrians, eliminating the risk of facial injury or damage to clothing,

prams and umbrellas from thorns and branches. Problems of this sort which affect any individual pedestrian can be most effectively and efficiently dealt with by reporting them to Durham County Council which has enforcing powers under the Highways Act 1980. PAVEMENTS AND CAR PARKING

There is usually no justification or need for parking on pavements where there are houses on only one side of a road. If you do decide to park on a pavement, please give consideration to pedestrians (for whom the pavements were solely built) and ensure that this fully allows for their safe passage. A maximum obstruction of up to one third of the pavement may keep you free from objections which police can be asked to enforce.

At its North Lodge site, Park View School is planning conversion work to create a room with availability to community groups for hire, out of school hours. In recognition of the Parish Council's agreed financial contribution of just under £4000 towards this work, the Council will receive free use of the room for up to twelve Parish Council meetings per year.

Low Flatts Path to Drum Pond & Drum Industrial Estate



Extremely grateful thanks to the voluntary environmental group from the Cooperative depot in Drum Industrial Estate's Unit 2, for its response to the Parish Council's request in clearing litter and vegetation, cutting back overhanging trees and repairing a fence over a culvert on the footpath between Low Flatts Bridge and Drum Estate. The photograph shows the excellent job done in improving access for walkers, cyclists, anglers and employees of Drum Estate.

For a very long time there has been a pond in this area (north east fringe of Unit 1) which has been enjoyed by anglers and those interested in tadpoles

and other pond life. The Parish Council has been trying to develop this into a community asset and was instrumental in having the pond retained and a footpath constructed to access it during the Gladman development construction of Unit 1 around ten years ago. This year, with Coveris (flexible packaging) as Unit 1's first tenant, this Drum Pond project will move forward following a Council instigated recent meeting of four Parish Councillors with the Environmental Agency, Coveris, County Councillor Peter May, and anglers.



Police Matters

Since taking over the G1A beat it has been my privilege to be invited to attend the Drum Industrial Estate Business Group meeting which is held each month. When I first attended the meeting, there were approximately 8-10 members. At the last meeting in March 2015 we had to move to a bigger venue at
